WINTER TEAM MEMBERSHIP and TRAINING FEES

FC Portland provides an 8-month training program for U15-U18 teams. Non-refundable Winter Team Fees for December 2010 thru July 2011 total \$1295 (\$395 Player Membership Fee plus \$900 Team Training Fee) and cover the following costs:

- Player training and coaches' compensation from May 2010 through July 2011.
 - All OPL League and League Cup registration fees for: the team, players, coaches, and managers.
 - For Girls' Teams only: Use of two uniform jerseys until the 2011-2012 season.
 - Use of game balls and other training equipment.
 - Use and maintenance of fields at Liberty HS and Hillsboro HS.
 - Administrative services from a professional staff.
- The following are among the costs not covered by Winter team fees. Expenses for travel, tournaments, and other optional competitions are shared by participating players.
- Required uniform and training gear, to be purchased at The Far Post.
 - Fees for the NWCL, WCDA or other training & competitive programs.
 - Team and coach travel expenses to League or League Cup games beyond Salem.
 - Team, coach, and manager travel expenses to any competitions or other tournaments requiring entry fees and/or travel.
