Welcome to FC Portland's U15-U18 Team Tryouts for the 2011-2012 soccer season!

### Who may attend tryouts?

If you are a player in good standing who was born between August 1, 1993 and July 31, 1997, you are eligible for selection to one of our U15-U18 competitive teams and welcome to participate in the Academy's tryout sessions for these age groups.

### How do I register for tryouts? What is the tryout fee?

Registration forms will be available in the FC Portland office and at [www.fcportland.org](http://www.fcportland.org) for early registration and at the fields for walk-up registration before each tryout session. The **non-refundable** tryout fee is \$40 if a player's registration form and fee payment is received in the FC Portland office by 9:00am Friday, August 5th. The **non-refundable** tryout fee is \$50 for registration forms and payments received after 9:00am, August 5th and at the fields for any walk-up registrants.

**If selected to a team, the Tryout Fee does not apply toward the \$495 Membership Fee or the \$900 Training Fee. The 2011-2012 season for U15-U18 players begins on 12/01/11 and ends on 7/31/12.**

### What happens after tryouts?

Players selected to U15-U18 teams will receive their invitation to become members **on the FC Portland website** by 2:00pm on Tuesday, August 9th. Selected players will confirm their acceptance, arrange to pay their **non-refundable Membership Fee**, and select a payment plan for their **non-refundable Training Fee** by 12:00noon on Friday, August 12th. Those accepting their invitations to join a team will be required to attend the 2011 All Academy Meeting (schedule and location to be announced at a later date). **Attendance by players and parents at this meeting is mandatory.** Following the introductory session, coaches will meet with their teams to discuss the competitive year ahead, including the start of team training and expected tournament participation. FC Portland staff will be present at the All Academy Meeting to answer your questions.

## WINTER TEAM MEMBERSHIP and TRAINING FEES

FC Portland provides an 8-month training program for U15-U18 teams. Non-refundable Winter Team Fees for December 2011 thru July 2012 total \$1395 (\$495 Player Membership Fee plus \$900 Team Training Fee) and cover the following costs:

- Player training and coaches' compensation from December 2011 through July 2012;
- Local competitive league registration fees for teams and US Club Soccer (USCS) membership fees for players, coaches, and managers;
- Regional Northwest Champions League (NWCL) or Western Collegiate Development Academy (WCDA) league fees for qualifying age groups;
- Use of game balls and other training equipment;
- Use of fields at Liberty High School and Hillsboro High School; and
- Administrative services from a professional staff.

The following costs are among those not covered by U15-U18 Membership and Training fees. Expenses for travel, tournaments, and other optional competition will be shared by participating players.

- Required uniform and training gear, to be purchased at The Far Post;
- Fees for optional tournaments, training, or other competitive programs;
- Team, coach, and manager travel costs to local or regional competitive league games and State or Director's Cup games past Salem; and
- Team, coach, and manager travel costs for USCS Regional competition or other tournaments requiring entry fees and/or travel.
